#### 1. Introduction

Werugha Welfare Association (WWA) respects your privacy and is committed to protecting your personal data in compliance with the **Kenya Data Protection Act, 2019**. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website <a href="https://werughawelfare.org">https://werughawelfare.org</a>. By accessing our website and using our services, you agree to the terms of this Privacy Policy.

#### 2. Information We Collect

We may collect the following types of personal data:

- **Identity Information** (e.g., name, ID number, gender, date of birth)
- Contact Information (e.g., phone number, email, postal address)
- **Membership Information** (e.g., registration details, payment records)
- Website Usage Data (e.g., IP addresses, cookies, browsing history)

#### 3. How We Collect Personal Data

### 4. Purpose of Data Collection

#### 5. Basis for Processing Personal Data

WWA processes personal data based on:

- Your **consent** when you voluntarily provide information.

### 6. Data Sharing and Disclosure

We may share your personal data:

- With authorized third-party service providers (e.g., payment processors, IT service providers).
- With government or regulatory bodies if required by law.
- When you provide consent for specific disclosures.

WWA **does not sell** or rent your personal data to third parties.

### 7. Data Security Measures

We implement appropriate **technical and organizational security measures** to protect personal data from unauthorized access, loss, or misuse. These include:

- Secure servers and encrypted data storage.
- Access control measures to limit who can view your data.
- Regular security audits and staff training on data protection.

#### 8. Data Retention

We retain personal data only for as long as necessary to fulfill the purposes outlined in this policy, unless a longer retention period is required. After this period, data will be securely deleted or anonymized.

## 9. Your Rights as a Data Subject

Under the **Kenyan Data Protection Act, 2019**, you have the following rights:

- **Right to Access**: Request a copy of the personal data we hold about you.
- **Right to Information**: to be informed of the use of your personal data.
- **Right to Correction**: Request corrections of inaccurate or outdated data.
- **Right to Deletion**: Request that we erase your personal data under certain conditions.
- **Right to Object**: Object to how we process your data for marketing or other purposes.
- **Right to Data Portability**: Request transfer of your data to another service provider.
